In order to ensure the safety of Electric Vehicle Charging Equipment and protect consumer rights, the BSMI proposes to include Electric Vehicle Charging Equipment (less than or equal to 30 kW), which is currently subject to Voluntary Product Certification (VPC) into the scope of mandatory inspection of the BSMI. Two alternative conformity assessment procedures are made available for the choice of applicants, i.e. Registration of Product Certification (RPC) or Type-Approved Batch Inspection (TABI). |
