- **Title, number of pages and language(s) of the notified document:** Draft Ministerial Regulation Prescribing Industrial Products for Recessed Luminaires and Recessed Air-Handling Luminaires for Use with LED Light Sources to Conform to the Standard B.E.; (21 page(s), in Thai)
- **Description of content:** The draft Ministerial Regulation mandates recessed luminaires and recessed air-handling luminaires for use with LED light sources to conform to the Thai Industrial Standard TIS 902 Part 2(2)-25XX(20XX) Recessed Luminaires and Recessed Air-Handling Luminaires.

This draft Ministerial Regulation applies to recessed luminaires and recessed air-handling luminaires for use with LED light sources for operation from AC supply voltages up to 1000 V, consisting of one of the following:

- 1) recessed luminaires and recessed air-handling luminaires with driver
- 2) recessed luminaires and recessed air-handling luminaires with LED light sources
- 3) recessed luminaires and recessed air-handling luminaires with driver and LED light sources

This draft Ministerial Regulation does not apply to blank luminaires.
