- **6. Description of content:** The draft Ministerial Regulation mandates prepainted hot-dip 55% aluminium/zinc-coated flat steel to conform to the Thai Industrial Standards TIS 2753-25xx(20xx).

This standard specifies technical specifications, characteristics, marking and labelling, sampling, and testing requirements for prepainted hot-dip 55% aluminium/zinc-coated flat steel, coating with a substance with aluminium and zinc as the main components, in the form of sheets, strips, and corrugated sheets with minimum thickness of 0.11 mm, with pitch of 76 mm and depth of 18 mm for large corrugated sheets, and pitch of 32 mm and depth of 9 mm for small corrugated sheets.
