Description of content:</b> Regulation of Minister of Industry No. 12 Year 2024 on Mandatory Implementation of Indonesian National Standard for Insulating Glass product produced nationally or imported, distributed, and marketed in Indonesia shall conform to SNI requirements. All Producers who produce these products shall perform compliance to those requirements, proven by having certificate SNI and SNI Marking product (SPPT - SNI). The product certificate for SNI marking shall be issued by product certification bodies that have been accredited by KAN and appointed by the Minister of Industry.  Directorate of Cement, Ceramic and Processing of Non-metal Material Industry, Ministry of Industry is the responsible institution for the implementation of this decree and shall provide a technical guidance of the decree, which covers procedure of product certification
