Description of content:** This document specifies the safety management and technical requirements for the design, manufacturing, construction, operation, management and maintenance of gas facilities in the factory area of industrial enterprises, including generating furnace, water gas furnace, semi-water gas furnace, upright continuous carbonizing furnace, blast furnace, converter, coke oven, ferroalloy furnace, etc.

This document applies to the gas facilities in the industrial enterprise factory area, not to the urban gas main pipe, branch pipe and courtyard pipe network and pressure regulating facilities.
